ATTENDANCE: All clubs were in attendance except: Bedford Golf, Twin Oaks, and Waccabuc.

MINUTES: Dan Levy (Chappaqua) made a motion that the minutes of the May, 2008 meeting be accepted as is; Margaret Kaplan (Lewisboro) seconded. Minutes were accepted unanimously.

TREASURER'S REPORT: A reminder was made that dues need to be paid to John Osterhoudt by June 24, 2008. Dues are now \$725.00 per team. The following teams currently owe dues: Pocantico, Waccabuc, Yorktown.

- Swim-a-thon: Leslie Hutton (Cortlandt) announced that, due to pool restrictions, she cannot invite outside swimmers to participate in the swim-a-thon (to raise funds for a scholarship in memory of her daughter, Beth). However, she will get information to us (via e-mail) on how to sponsor a swimmer.

- Changes need to be made to the B Meet schedule and will be done in the next few days. This info. will be sent to all clubs via e-mail and posted on the website.

NEW BUSINESS:

- Susannah Rudel of Chappaqua Swim and Tennis will be sponsoring "Summer Swimmers' Fighting Hunger" again this year. She started it last year as a Girl Scout project and 10 teams participated. She encouraged all to participate this year and had information available at the meeting.
- Kevin Mullaney (Katonah) asked if a swimmer who resides in Katonah but goes to Bedford Hills schools can swim for Bedford Hills. Discussion ensued and Michael Panzarino requested that he get more specific information from the recreation department.
- Carolyn Johnson was available after the meeting to answer questions for those hosting championship meets this year.
