

# NORTHERN WESTCHESTER SWIMMING CONFERENCE

Michael Panzarino, President, welcomed everyone to the meeting at 7:11 p.m. at the Boys and Girls Club in Mt. Kisco.

**ATTENDANCE:** All clubs were in attendance except: Bedford Golf, Twin Oaks, and Windmill.

**MINUTES:** Carolyn Johnson made a motion that the minutes of the March 25, 2008 meeting be accepted as is; Greg Sims (A.L.E.) seconded. Minutes were approved unanimously.

**B MEETS/CLUB INFO:** Bea Rhodes asked that the B Meet Sign-up sheet as well as the Club List Update form, and corrected driving directions (including the street #, where applicable) be submitted to her as soon as possible, but no later than May 30<sup>th</sup>.

**TREASURER'S REPORT:** John Osterhoudt was not able to attend, so Michael Panzarino reported that club dues are due no later than June 24<sup>th</sup>, 2 weeks prior to the first meet, and rosters are due by July 1<sup>st</sup>. **ELECTIONS:** Dan Levy (Chappaqua) of the Nominating Committee reported that no one volunteered to run against incumbents Michael Panzarino, John Osterhoudt and Carolyn Johnson, so Patty Kelly nominated all three and they were elected unanimously.

## **OLD BUSINESS:**

- At the last meeting a discussion was held regarding swimmers' eligibility to swim for both NWSC and WCSC teams. Patty Kelly made a ***motion that we add wording that they must be "dues paying members" to both leagues*** before adding this to the constitution.
