Reminder: to be eligible to swim or dive in championships the individual must have participated in two meets which can include B Meets.

**Jobs on Website:** Please let us know when your job has been filled so that we can remove the listing from the website.

**Lane cards:** A swimmer's first and last name(s) must be filled out on the lane card when the lane card is submitted to the timers. This includes all relays. If the timer notices that the name(s) is not filled out properly on the card then the coach should be notified. If the lane card is not completed properly before the race begins then the swimmer(s) is disqualified.

**Championship Meet Hosts:** The host needs to review the constitution and be completely aware of their responsibilities. Every team participating in the championship meet must have a scorer, ribbon writer and timers.

Motion: The host for each division championship meet (swimming and diving) will give original score sheets to Michael Panzarino. All championship score sheets will be scanned and PDF files created which will then be sent to all of the participating clubs as well as posted on the website. Motion to accept – Lewisboro. Seconded – MKMP. Unanimously approved.

**7. New Business: Westchester County Swim Officials Scholarship (WCSO):** Each March the northern Westchester Swim Conference proposes a contribution of \$100 to the WCSO Scholarship. This year's recipient of the scholarship was Charlie Carr who swims on the Twin Oaks swim team in the Northern Westchester Swim Conference.

Monique Grayson our webmaster was inducted into the Metropolitan Swimming Association's Hall of Fame. The Northern Westchester Swim Conference would like to recognize Monique for her contributions to the NWSC as well as her impact on the sport of swimming in Metropolitan New York.
