**Call to order:** The meeting was called to order at 7:07 by Mike Panzarino, President. Executive Committee members in attendance: Meg Kaplan, Carolyn Johnson, and Kelly Blacker. Absent: John Osterhoudt.

**1. **4. Team rosters** - Due to John Osterhoudt by June 22, 2017. **REMINDER: a swimmer or diver must be officially added to your roster TWO DAYS PRIOR to the meet that you wish them to compete in. This includes B Meets.** John has received rosters from Briarcliff and Seven Bridges. John's contact information is on the website.

**5. Championship Sites & Meets** – Please note that participation is required by all – host clubs should contact teams one week prior to the meet. Awards, banners, score sheets and lane cards are to be delivered to each pool by John Osterhoudt or Carolyn Johnson. It is the responsibility of the diving championship site to deliver the banner to the swimming championship host. The hosting facility for swimming championships will bring the banner to All Star swimming. The color coded lane cards are for use at All Stars not the championship meet. All diving sheets are on the website. Please make sure you are using the right dive sheet as they are different for A meets, B meets, and championship meets.

**B Meets:** The B meet schedule is on the website. If you are hosting, contact teams prior to the meet. If you cannot attend please let the host team know in advance. B meet rules: No jumps for B dive meets and no in water assistance for B swim meets. If an “A” swimmer needs to qualify for Championships they can swim at a B meet, just let the host club know. B meet warm up is at 4:30 with a 5:00 start. Try to reschedule a B meet if it is cancelled.

**6. Dual Meets:** No changes to events or event distances are allowed. Clubs that do not have diving: BG&T, Cortlandt, MKCC, Peekskill, Pleasantville, Seven Bridges, Waccabuc, Whippoorwill, Windmill. First and last names must appear on the lane cards.

**8. Scoring Clinic:** Everything presented at the scoring clinic will be on the website. Please note that Championship meet scoring is different than in the Dual meets.
