8. Eligibility of Lifeguards & Coaches - Athletes employed as lifeguards or other summer employment may only compete for the NWSC team appropriate to their municipality of residence or the club at which they are bonafide dues paying members. If neither is applicable, requests must be made to the Rules and Procedures Committee at the June meeting each year and decisions from prior year are grandfathered in as long as there were no changes. Furthermore, members of the same family must swim at the same club.

9. Rules: Diving and Misc.: Lifeguards and coaches should not be in the water at B meets. The swimmer is the only one allowed in the lane during a swim meet. No lifeguard suits allowed for meets. Need to wear a team suit or a generic suit.

Please use the correct dive sheets. There are different dive sheets for Dual meets, B meets and championships. The first dive should be a mandatory dive 101A, B, or C. Then allowed three other dives out of five groups.

To reschedule a meet, speak to the official first.
